Have you ever wondered how the staff at The Children's Collective, Inc. stays current with all the administrative and program issues of City, County and State funders and regulators?

The staff stays current on these issues due to Quarterly trainings by the Management Team (upper right —Standing l-r: Coral Forbes, Yolanda Walters; Seated l to r: Sharon Smith & Jackie Kimbrough, Ph.D., Executive Director). More than 120 staff usually attend the day-long trainings at local hotels. Professional speakers address issues such as the Impact of Immigration Reform on Clients and Families, Toxic Stress, Avoiding Sexual Harassment and Productive Communication. Personal Development topics include Financial Planning and Caring for Yourself While Caring for Others.

According to Dr. Kimbrough, the trainings provide staff with knowledge and tools to help improve life outcomes for clients. The trainings also provide staff from 15 scattered locations the opportunity to meet, mix and mingle with one another.



RWLC OFFERS FREE TAX RETURN PREPARATION



The Volunteer Income Tax Assistance (VITA) program offers free tax help to people who generally make \$54,000 or less, persons with disabilities and limited English speaking taxpayers who need assistance in preparing their own tax returns. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals.

In addition to VITA, the Tax Counseling for the Elderly (TCE) program offers free tax help for all taxpayers, particularly those who are 60 years of age and older, specializing in questions about pensions and retirement-related issues unique to seniors. The IRS-certified volunteers who provide tax counseling are often retired individuals associated with non-profit organizations that receive grants from the IRS.
